Dear Delegates and Guests of the 5th Annual Conference of the LDRN,

It is my great pleasure to welcome you to the 5th Annual Conference of the Law and Development Research Network, which we have themed – "Beyond the Crisis: Challenges and Opportunities for Law and Development". Although hosted virtually, the Faculty of Law at Nelson Mandela University is both proud and delighted to welcome you to Gqeberha (Nelson Mandela Bay) in the Eastern Cape Province of South Africa.

The LDRN was founded in 2017 to enhance our knowledge and understanding of the role of law in relation to development and governance. We aim to share our collective knowledge to understand better the role that law plays in creating, causing and combatting inequality, environmental degradation and social injustice, particularly in the Global South. The LDRN annual conferences are an excellent vehicle to explore these issues in a collegial setting and in a manner which promotes and advances solution-driven research.

After the outbreak of the COVID-19 pandemic, the role of law has become significant as a means to address, and overcome, the immense developmental challenges our world faces. These challenges have placed strain on healthcare systems, economies, our way of life, vulnerable persons, legal systems and domestic mechanisms of governance. Although felt worldwide, the impact of the pandemic has been experienced most severely by people living in the South. It is thus fitting that the first conference of the Network after the outbreak of the pandemic is hosted in the Global South, in South Africa, and by an institution named for one of the world's greatest statespersons, Nelson Mandela. It is even more significant that this is the first time that the Network's annual conference is hosted in the South by a Southern Partner.

Over the next three days, more than 200 scholars of Law and Development (who come predominantly from the Global South) aim to address and propose solutions to the many challenges created by the pandemic, specifically from a Global South and developing world perspective. We are particularly excited at the interest shown by scholars coming from Africa, the Americas and the East. We look forward to meeting you, engaging with your ideas and forging future relationships. Undoubtedly, the connections formed at the conference will enhance the Network and our work.

The conference provides a virtual platform for you to meet each other and to share your ideas. We have created nine virtual rooms. Seven are based on the various conference tracks (see the key below) and one, called the Mandela Room, will be used for extra sessions and panels, that cannot be accommodated in the theme-based rooms. We have also created a Networking and Keynote Room for plenaries. This Room will be open throughout the conference and can be used at all times by delegates to network and discuss anything of interest, including presentations, research and future engagement. Please use the Room as your space to engage with each other – you'll note that you can move between tables to create a private space or to engage with colleagues. We are honoured to host two prominent keynote speakers. We welcome Prof Dire Tladi of the University of Pretoria, who will speak to us about *The Potential for Environmental Jus Cogens* on

the evening of Thursday, 25 November and Prof Sakiko Fakada-Parr of the New School in New York, who will address us on *Human Rights and the Pandemic in the Age of Hyper-globalization* the evening of Friday, 26 November. On the 24th of November we have arranged a panel discussion with Daniel Bonilla, Kevin Davis, Matthew Erie, Ada Ordor and Mariana Pargendler. We have asked them to interrogate the way in which law and development can best respond to the challenges and opportunities presented by the pandemic. Our aim is to set the scene for the conference, to consider whether there are separate Southern and Northern perspectives on law and development, and, if so, how these can be best reconciled to overcome the tensions between the North and the South.

Please bear in mind that Nelson Mandela University and the LDRN promote open and constructive debate about law and development. To this end, we call on all participants to engage in discussions with courtesy and respect.

We thank Nelson Mandela University for providing funding and institutional support for this Conference. We also thank the South African National Research Foundation and LexisNexis for their funding. The Organising Committee comprised Prof Marius Olivier, an Honorary Professor at Nelson Mandela University and a Fellow of the Stellenbosch Institute for Advanced Study (STIAS) and Prof Patrick Vrancken, the incumbent of the SARChl Chair in the Law of the Sea and Development in Africa at Nelson Mandela University.
