Daria DAVITTI is Associate Professor at Lund University, Faculty of Law. She is a public international lawyer specialized in international investment law and international human rights law. Her current work focuses on the human rights impacts of climate finance and refugee finance. Her research focuses broadly on law and development, with a particular interest in sustainability, Human Rights and international financial institutions. She holds a law degree from the University of Geneva, an LL.M. from NYU and a PhD from the University of Geneva. Professor Erie is trained in both law and anthropology & studies comparative Asian law. He has written on Chinese domestic law (e.g., property law and constitutional law), international law (e.g., dispute resolution, conflict of laws, anti-corruption law, and investment law), & Islamic law (e.g., personal status law, finance, charity, and property). His work has either appeared in or is forthcoming in such journals as the Harvard International Law Journal, American Journal of International Law Unbound, Yale International Law Journal, Virginia Journal of International Law, American Journal of Comparative Law, NYU Journal of International Law & Politics, Chinese Journal of Comparative Law, Asia Pacific Law Review, Law and Social Inquiry, and American Ethnologist. His first book, *China and Islam: The Prophet, the Party, and Law* (Cambridge University Press, 2016), is the first ethnographic study of the relationship between sharia and state law in China. His current research project “China, Law and Development,” funded by a European Research Council Starting Grant (€1.5 million), examines China’s approach to ordering within international law and the legal and regulatory systems of host states receiving Chinese capital. Professor Erie previously held academic positions at Princeton University and NYU Law School, and he was a visiting scholar at the National University Singapore Law Faculty. In the fall 2018, he was a Global Research Fellow in the Hauser Global Program of NYU Law School. He is also an Adjunct Researcher at the Jiaotong University Koguan Law School. He practiced law in the New York and Beijing offices of Paul Hastings LLP where he focused on corporate real estate transactions and white-collar investigations (e.g., FCPA).
